telephone number [redacted] were also present during the interview. After being advised of the nature of the interview, PEGEEN CUSHING provided the following information:

PATRICIA CUSHING, W/F, Date of Birth 02/13/32, resided at 7 East Court, Bayonne, New Jersey for 13 years. PATRICIA CUSHING was born in Baltimore, Maryland and did not maintain a residence outside the United States. PATRICIA CUSHING retired from Bell Atlantic as a service representative and had no known security clearances or prior military service. PEGEEN CUSHING advised her mother PATRICIA was a passenger on United Airlines Flight 93, on September 11, 2001 with her aunt JANE FOLGER. FOLGER and CUSHING were traveling to San Francisco, California for a vacation. The ticket for PATRICIA CUSHING was a gift from a niece. A taxi from Archie's Cab Company, Bayonne, New Jersey transported CUSHING and FOLGER to Newark International Airport on the morning of September 11, 2001. CUSHING utilized one large black suitcase, one carry on bag and a handbag to carry her belongings for the trip. DAVID CUSHING'S last contact with his mother was on September 10, 2001, at approximately 9:15 p.m.

DAVID and JOHN CUSHING, sons of PATRICIA CUSHING, and PEGEEN CUSHING, daughter of PATRICIA CUSHING would like any recovered personal effects of PATRICIA CUSHING returned to them as well as being kept apprised of the investigation.

Victim/Witness Assistance brochures with the name and telephone number of the Victim/Witness coordinator were provided to PEGEEN and DAVID CUSHING.
