In Jeddah, Saudi Arabia, Alnami obtained a second multiple entry visa (B1/B2), valid until 4/22/03, using Saudi Arabian passport #C505363. This time he gave 6368842 as his home phone. Alnami crossed out the name he had put down as a traveling companion and wrote "alone." He wrote that he was visiting Florida ["florede"] for two to three weeks. (NK, SA [REDACTED])

May 26

Alnami, Mohand Alsheri (UA 175) and Hamza Algamdi (UA 175) purchased their one-way tickets together for \$8,460 (United Arab Emirates [UAE] currency) which converts to \$2,350 (USA - \$783 each). The tickets were purchased in Dubai, UAE. (Virgin Atlantic Airlines faxed a PNR Body report on this.) (NY-280350, Serial 4350)

May 28

INS indices revealed that Alnami, Alsheri (UA 175) and Algamdi (UA 175) departed Dubai on Emirates Airlines 7 at 2:15 am on 5/28/01, and arrived at London Gatwick at 6:55 am. The group then departed Gatwick on Virgin Atlantic Airlines 5 at 10:45 am and arrived in Miami at 3:15 pm. The group gave Virgin Atlantic Airlines a contact of MUSTAFA/B 050 7696327 or 06 5725252. (NY-280350, Serial 4350) Alnami traveled on a B2 visa, valid through 11/27/01. (Chronology: 9/11/01, 10 pm, NY 473). He provided the address of a Sheraton Hotel in Miami. Ahmed A. A. Alnami, Marwan Alshehhi (UA 175), Mohamed Atta (AA 11), Sageed Alghhandi [Saeed Alghamdi, UA 93] and two unknown individuals stayed at the Deluxe Inn, 1150 S. Federal Highway, Dania, FL, from 6/11/01 to 6/14/01. The registration card filled out in Alnami's name by Alshehhi was entered into evidence for possible latent prints. (NY-280350-MM, Serial 3255)

June 17

[redacted] had a chance encounter with Alnami on Father's Day 2001 at a gun show at the Ft. Lauderdale war memorial. [redacted] was waiting at the door for his daughter to come out of the bathroom. Alnami thought [redacted] worked there and asked how to purchase a gun without the paperwork and having to wait. [redacted] advised that it was not possible and Alnami stated his understanding was that he could deal with one individual to avoid the paperwork. (NY-280350-MM, Serial 3193)

Alnami called UA's Bloomington office checking on the status of the two tickets he ordered on 8/27/01, at which time he was advised of the declination. Approximately 38 minutes later, Alghamdi contacted UA's Burbank office and provided Visa credit card number 4011806070840805 (exp. 7/03). The second credit card number was approved and e-tickets were issued for both Alghamdi and Alnami. The purchase price of the tickets totaled \$3,539.50. Alnami and Alghamdi were assigned seats 3C and 3D, respectively. (NY-280350-A, Serial 16)

Alnami and Alghamdi visited Mile High Travel/Chambers Travel, 250-A Commercial Boulevard, Lauderdale By The Sea, FL. They paid cash for two tickets on Spirit Airlines flight 1460 leaving at 6:35 pm from Ft. Lauderdale, FL, and arriving at 9:30 pm in Newark, NJ, on 9/7/01. (NY-280350-MM, Serial 1613) In booking their flight, they provided contact number 514-748-2522, which belongs to Vision Travel, 100 Boulevard - Alexis Nihon, Quebec, Canada. September 7

\$4,400 was withdrawn from the account via check presented to a branch of SunTrust in addition to \$500 withdrawn from an ATM. (NY-280350-BS, Serial 352)

Alnami and Alghamdi flew from Ft. Lauderdale, FL, to Newark, NJ, on Spirit Continental Airlines. Four used tickets for Alghamdi, Alhaznawi, Alnami, and Ziad Jarrah found in Newark Day's Inn rooms. (Chronology: 9/12/01, 10:30 pm, NK)

September 8

Alnami and Alghamdi arrived together in Newark, NJ. They checked into Newark Airport Marriott Hotel at 12:31 am with Jarrah. A videotape at the hotel shows Alnami entering the Marriott on 9/8/01 carrying two bags, a medium sized dark-colored suitcase with wheels and "telescopic" handle and with a shoulder strap, a large, dark (possibly green) gym bag with no visible markings. (NY-280350-NK, Serial 364 & 1727; -PG, Serial 303)

September 10

Credit card/debit charges at Kinko's #1232, 55 Route 22 East, Springfield, NJ, in the amount of \$22.15, and at the Citgo Gas Station #5234, Cliffside, NJ, in the amount of \$6.74 and \$3.99. (NY-280350-SL, Serial 152) Alghamdi and Jarrah entered the Kinko's store at approximately 4:04 pm, stayed on the Internet for 58 minutes, and printed seven pages. They then proceeded to the ticket counter where Jarrah presented Alnami's credit card to pay the \$22.15 in fees charged by Kinko's, but when the clerk handed him the credit

card receipt to sign, he picked up the receipt and handed it to the Alghamdi, who appeared surprised. The men then spoke in a foreign language that was not Arabic, then Alghamdi signed the receipt. Jarrah and Alghamdi then left Kinko's at approximately 5:08 pm. (NY-280350-NK, Serial 1293)

(LES) Alnami stayed at the Newark Airport Days Inn; evidence collected by Newark provided a positive identification. (CTD Summary VI, 9/17/01; NY-280350, Serial 2268)
