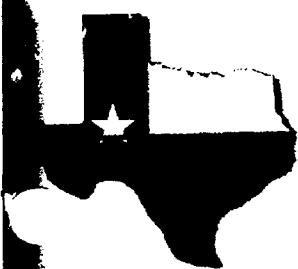

Subject ALGHAMDI entered the U.S. on 2MAY01 with Majed MOQED (identified terrorist on American Airlines flight #77). On this same day, terrorist Marwan Alshehhi (also on American Airlines flight #175) entered the U.S. on Northwest Airlines flt #57 to Miami.

TECS II SQPQ search reveals several DOBs for this subject; TECS record P9B38772200CDA list this subject with passport number 346541 (PPN 346541 belongs to Ahmed ALGHAMDI with a DOB of 9/13/69 not 7/2/79).

Due to the rapid and numerous inputs into TECS in order to identify the terrorist from September 11th, there have been inconsistencies and lack of integrity maintained with various TECS records. To date, it is unsure which information has been verified.

It is possible that subject ALGHAMDI lived with terrorists Nawaf ALHAZMI and Majed MOQED at 5913 Leesburg Pike, Falls Church, Virginia. Subject entered the U.S. with MOQED, therefore, it is highly probable that he lived at MOQED's residence.

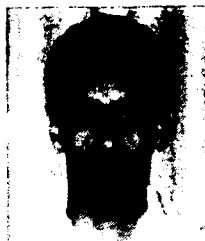

Terrorist Timeline

03SEP00	B2 Visa issued in JEDDAH
02MAY01	Entered the U.S. on B2 Visa in Washington D.C. (UA, Flight 925) from London, England with Majed MOQED
02AUG01	1ALGHAMDI, HANJOUR, MOQED, Salem ALHAZMI, and ALOMARI obtain Virginia driver's licenses or State Identification Cards
29AUG01	2Ahmed & Hamza ALGHAMDI reserved electronic tickets (one-way) on United Airlines Flight 175
10SEP01	1Ahmed & Hamza ALGHAMDI stay at the Days Inn on Soldiers Field Road in Brighton, MA, outside of Boston
11SEP01	2Hazma ALGHAMDI, BANIHAMMAD, Mohand ALSHEHRI, Ahmed ALGHAMDI, and ALSHEHHI hijacked United Airlines Flight 175, A Boeing 767, which had departed from Boston; they flew flight 175 into the South Tower of the World Trade Center.
