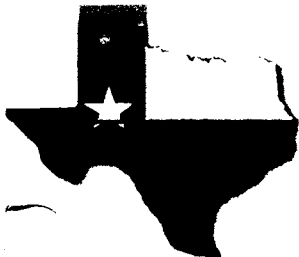

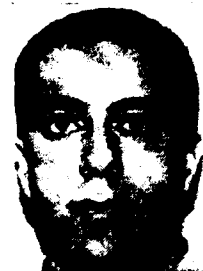

1998	2Ramzi Bin AL-SHIBH, Mohammed ATTA, Marwan AL-SHEHHI, Ziad JARRAH, and others, formed an al Qaeda terrorist cell in Germany

Aug00	2Attempted to enroll Ramzi Bin AL-SHIBH in a flight school in Florida
25NOV00	Entered the U.S. in Miami
26DEC00	Departed the U.S. from Miami (NG, Flight #32)
05JAN01	Entered the U.S. on a B2 Visa in Newark, NJ (CO, Flight #37) from Germany
26JAN01	Departed the U.S. (CO, Flight #36) from Newark, NJ to Germany
25FEB01	Entered the U.S. on a B1 Visa in Newark, NJ (CO, Flight #37) from Germany
30MAR01	Departed the U.S. from Atlanta (KL, Flight #622)
