LOCATION TIME LINE

June 1, 2001: Stamp with this date appears on Al-Haznawi's passport from Bahran International Airport. (source: photocopy of passport).

June 8, 2001: Travel to Miami, FL. On Virgin Atlantic flight 5 from London Gatwick. Travels with Wail Alshehri (Flight 11). Al-Haznawi's passport bears a stamp from U.S. immigration confirming his arrival in Miami on June 8, 2001. This flight originated in the United Arab Emirates (UAE).

June 17, 2001: Al-Haznawi begins residence at 4641 Bougainvilla Dr.

June 25, 2001: Al-Haznawi is admitted to and discharged from the Holy Cross Hospital in Ft. Lauderdale, FL, obtaining treatment for a leg infection. He reported Ziad Jarrah as his next of kin, and reported a DOB of 6/18/78. He reported his address as 4641 Bougainvilla Dr.

July 12, 2001: Al-Haznawi's bank account (#0686001066806) is opened with a deposit of \$500. (FBIHQ Financial Review Group)

July 17, 2001: Al-Haznawi deposited 5 \$100 American Express Traveler's Checks. (FBIHQ Financial Review Group)

July 18, 2001: Al-Haznawi deposited 5 \$100 American Express Traveler's Checks. (FBIHQ Financial Review Group)

July 20, 2001: Al-Haznawi deposited 5 \$100 American Express Traveler's Checks. (FBIHQ Financial Review Group)

August 8, 2001: A charge to Alhaznawi's debit card was made, payable to the Middle East International Institute (\$57.49). (265D-NY-280350-SL.152.ACS, p.2)

August 10, 2001: ATM withdrawal of \$60.00. (FBIHQ Financial Review Group)

August 13, 2001: A charge to Alhaznawi's debit card was made, payable to the Middle East International Institute (\$13.74). (265D-NY-280350-SL.152.ACS, p.2)

Comment: Ziad Jarrah had a charge to his account on 8/26/01, payable to the same organization. (265D-NY-280350-SL.152.ACS, p.2)

August 29, 2001: Booked a ticket on United Air Flight #93 through Travelocity.com from a Kinkos Internet protocol and used the telephone number 954-771-0620 with the address 4641 Bougainvillea Drive, Lauderdale by the Sea, Florida 33308. (HQ1808, NY-280350-A, Serial 5)

Records obtained from Travelocity indicate that Al-Haznawi accessed the Travelocity Internet site from IP address 204.120.56.1 from 9:54 PM until 10:09 PM.

Al-Haznawi's account receives a \$600 deposit. (FBI Boston).

A charge of \$1721.50 is made for the purchase of a United Airlines ticket. (FBI Boston).

August 30, 2001: Al-Haznawi moves out of the 4641 Bougainvillea Dr. address.

August 31, 2001: \$100.00 debit is charged to Al-Haznawi's bank account

Al-Haznawi moves into 4532 Bougainvillea Dr., Apt.2, Lauderdale by the Sea, Florida.

September 5, 2001: Al-Haznawi and Jarrah purchase one-way tickets for Continental Airlines, flight 1500, departing on September 7 from Ft. Lauderdale, bound for Newark. The tickets were purchased with cash (265A-NY-280350-302; serial 3852).

September 6, 2001: \$60.00 debit is charged to Al-Haznawi's bank account.

Note: On September 6, 2001, a \$520.50 debit was charged to the VISA card of Saeed Al-Ghamdi, another of the UA Flight 93 hijackers (265A-NY-280350; serial 1881).

September 7, 2001: Al-Haznawi moves out of 4532 Bougainvillea Dr., Apt. 2, Lauderdale by the Sea, Florida.

Comment: All debits charged to Al-Haznawi's account from 8/30/01 - 9/7/01 were payable to a business at [redacted] as was the 9/6/01

debit charged to Al-Ghamdi's VISA card. Choicpoint searches conducted by investigators revealed that a business known as [REDACTED] is housed at this address. Additionally, investigators placed a pretext phone call to the business located at this address; the answering machine confirmed that [REDACTED] is located at this address. The nature of the business/entity is unknown at this time (265A-NY-280350; serial 1881).

Comment: *It should be noted that the debits charged to Al-Haznawi's account totaled \$520.50, the precise amount charged in the 9/6/01 debit from Al-Ghamdi's VISA card (265A-NY-280350; serial 1881).*

September 7, 2001: Al-Haznawi is issued a duplicate driver's license.

September 7, 2001: Travels from Ft. Lauderdale, FL to Newark, NJ on Spirit Continental Airlines, flight 1700, departing 8:35 p.m. and arriving at 12:20 p.m.. Four used tickets for SAEED ALGHAMDI, AHMED ALHAZNAWI, AHMED ALNAMI, ZIAD JARRAH found in Newark Day's Inn Rooms (Chronology: 9/12/01, 10:30 p.m., NK).

As of 9/7/01, Al-Haznawi's account possessed a balance of \$22.72. (FBI Boston)

September 11, 2001: (LES) United Airlines provided information to FBI NK regarding the hijacker's baggage on United Airlines Flight #93. Ahmad Al-Haznawi had at least one checked bag. The bag(s) was run through a scanner/MRI during screening. (CTD Summary VI, 9/17/2001)

7:24 am: Checked in for the flight. (9/16/01, 10:30 p.m., NK)

7:39 am: Boarded the plane and took seat 6B (9/16/01, 10:30 p.m., NK)

8:01 am: UA Flight #93 departed the gate at Newark, bound for San Francisco

8:42 am: UA Flight #93 left the ground at Newark.

9:28 am: Hijack of UA Flight # 93 begins, based on Flight Data Recorder and Cockpit Data Recorder.

10:02 am: UA Flight #93 crashed in Pennsylvania.
