Abdul Aziz ALOMARI entered the U.S. along with terrorist Salem ALHAZMI (Flt #77 Dulles to LA) on Flt #100.

Due to the rapid and numerous inputs into TECS in order to identify the terrorist from September 11th and develop future leads of terrorism, there have been inconsistencies and lack of integrity maintained with various TECS records. To date, it is unsure which information has been verified.

Subject is listed with dates of birth (12241972, 05281979) in TECS 9PB53612400CIQ and 06281976 in TECS 9PB55069900. TECS 9PB53609400CIQ states that subject ALOMARI has two brothers, Ali Saeed ALOMARI and Abdulrahman Saeed ALOMARI (Pilot) (Net Diagram attached).

There was a Saleh ALOMARI with the DOB

There are no indications that this individual is related to any of the terrorist, however it should be noted that the last name and DOB are the same.

Terrorist Timeline

	B2 Visa issued in JEDDAH
29JUN01	Entered the U.S. in New York, Swiss Air Transport, Flight #100 from Zurich, Switzerland with Salem Alhazmi
01JUL01	1ALOMARI, Mohamed ATTA, Wail ALSHEHRI, Waleed ALSHEHRI, Satam Al SUQAMI, Marwan Al-SHEHHI and Fayez BANIHAMMAD register for one-month membership at World Gym in Delray Beach and Boynton Beach
02AUG01	1ALOMARI, Hani HANJOUR, Majed MOQED, Salem ALHAZMI and ALGHAMDI obtain Virginia driver's license and ID cards
28AUG01	1ALOMARI buys ticket over AA Web Site using Mohamed ATTA'S Aadvantage account. ALOMARI uses the same visa card as Mohamed ATTA, listing the same mail box address as Mohamed ATTA and Marwan Al-SHEHHI and the same phone number as Mohamed ATTA and Wail and Waleed ALSHEHRI.
28AUG01	2ALOMARI and Mohamed ATTA reserved two seats on American Airlines Flight 11
06SEP01	2ALOMARI and Satam Al-SUQAMI fly from Florida to Boston
10SEP01	1ALOMARI and Mohamed ATTA stay at the Comfort Inn, South Portland Maine
11SEP01	2ALOMARI and Mohamed ATTA fly from Portland, Maine to Boston, Massachusetts
11SEP01	2ALOMARI, Mohamed ATTA, Satam Al-SUQAMI, Wail ALSHEHRI and Waleed ALSHEHRI hijacked American Airlines Flight 11, a Boeing 767, which had departed from Boston; they flew flight 11 into the North Tower of the World Trade Center.
